#### TREASURERS REPORT 2017

This year resulted in a surplus of some \$4,342 with the bulk of this being a "one off" in our match receipts with the balance a result of previous initiatives (guest policy & money hole).

While we had an intake of some 44 new members, this was down from last years 50 and total members are down 16 from last year. The fall in membership has an effect on income and we cannot be too complacent as the current years budget is basically break even. On the expense side these were pretty well controlled with some additional expense in relation to the upgrade of the web site but overall down slightly from last year.

I would like to thank Stewart Ley our Secretary for the time and effort put into the District, also thanks to Kevin Milner as our Webmaster – his expertise in computers is of great advantage to our Membership and also to Ian Tait who has overseen the enhancements on our new look website. My thanks also to the members of the Operations Team who look after the cash on game days.

There will be no change proposed for our annual fees (\$40 with a rebate of \$5 to those Members who have attained the age of 70 and have completed five years of membership) or the nomination fee which will remain unchanged at \$80

Our auditor for many years Grant Fyffe retired at the end of last year & I would like to thank Grant for his advice and assistance to our Association over this period.

I have pleasure in presenting these accounts to the Membership and would propose that the Audited accounts as presented be approved and in accordance with our Constitution that the annual and nomination fees as mentioned also be approved.




