# **CAPTAIN'S REPORT for 2019**

The 2018/19 season so far has again been very successful and well attended by members and guests. The number of games in the 2019 schedule is twenty and playing each course once (with the exception of Southern and Cranbourne).

Unfortunately, we had to cancel the scheduled April game at the new Peninsula Kingswood Frankston site primarily as a consequence of the scheduled course not being completed - (17 holes including 1 temporary). The rest of the course was in excellent condition. The cancellation of this game was given careful consideration by the committee, but the major concern was meeting the expectations of MDVGA members and providing value for money.

As a replacement for Peninsula Kingswood, Secretary Cec Bailey managed to secure a booking at Settlers Run on Tuesday April 16 and an *afternoon* start at 12:30. The event was a Gentsomes four man team event – best drive taken and then a standard stableford play with best 2 scores counting. This provided the match committee with a fast and efficient method of score processing after the event. Settlers Run has now been included in our game roster for 2020.

The annual Melbourne verses Dalhousie challenge match at Kilmore GC had to be cancelled as we had two issues concerning holding the event. They were the difficulty in generating interest from a sufficient number of our members and also as a result of the extraordinarily dry conditions early this year and lack of rain, it was felt the Kilmore course standard would not meet the expectations of our members.

During the last year we have welcomed thirteen new Lady members into our association, and we trust they enjoy all the benefits and comradery the Vets has to offer.

We continued to offer a selection of "premium" sand belt courses in Royal Melbourne, Yarra Yarra and Woodlands. Once again this proved popular with members.

# **SECRETARY'S REPORT 2019**

After taking over the position of secretary from Stewart Ley last year I have had great support from Len Symons, John Anstey, Stewart and other committeemen to make my transition to secretary much easier. I now realize the tremendous amount of effort of all committeemen that goes into making the MDVGA a successful Golf Association and the smooth running of the 18 or so golf games we play over the year.

We welcomed the introduction of lady members to our Association this year and they have added another dimension to our regular games. Going forward we will be introducing some initiatives with the intention to make them feel more inclusive. Let's hope we can increase our ladies membership into the future.

Our Association has enjoyed playing at "Tier 1" clubs such as Commonwealth, Royal Melbourne and Yarra Yarra in past years but unfortunately such clubs are changing their rules regarding "Corporate days" and as such making green fees a little too expensive for most of our members. As an example Royal Melbourne charged us \$155 this year of which \$15 was subsidised by MDVGA. Next year under proposed changes they are looking at charging \$300 plus – way out of our league. Unfortunately they fail to realize that we are not a corporate entity with tax exemptions, but a group of experienced club members looking to play on other quality courses around Melbourne for a reasonable price. Commonwealth on the other hand wanted our members to prepay on booking. This would be a nightmare for our MDVGA voluntary committee as it would involve much more time and effort. Huntingdale quoted us \$225 for a game. Although Peninsula/Kingswood is not rated as a "Tier 1" club (yet) they were asking for a \$200 green fee to play at their remodelled course this year which again we thought was way above what our members would pay. If we don't play Royal Melbourne next year we will have a good winter break from mid-June to mid-August – plenty of time to head to the Gold Coast for some warmth and sunshine!

I feel we have a good mix of quality courses at reasonable cost and hope we can maintain this mix into the future. A new course that has been added to the syllabus for next year is that of Settlers Run in Cranbourne South/Botanic Ridge although some of us did play there this year when the Peninsula/Kingswood game could not be facilitated. Another initiative for this year and hopefully into the future is the challenge match between MDVGA and the Mornington Peninsula Vets which will take place at Devil Bend golf course on Monday October 14.

I have enjoyed the visitations to the various courses we play during the year mainly conducted between January to March meeting the Event Co-ordinators or General Managers to discuss various aspects of their courses in preparation for our games. As secretary I will endeavour to undertake the occasional survey to obtain your thoughts and feelings of our performance and course selection. I did one impromptu survey after the Settlers Run game with very positive results.

Congratulations to all our game day winners and our major trophy winners; Dale Collins, Roger Bain and Russell Scott.

Thank you to all you, our members for supporting the games and introducing guests and new members and I hope to get to know you all better in the coming years.

# TREASURERS REPORT 2019

This year resulted in a small cash deficit of some \$596 following the replacement of the Match laptop. While our income was up by \$2,200 in the main relating to a larger than normal intake of some 60 new members which resulted in a net increase of 8 members. On the expense side these were pretty well controlled with the total expenses up by \$5,003 mainly, \$1,550 in game costs (game day subsidies, trophies & balls), Name Badges \$340, Insurance costs \$270 and Web & Computer related costs (Laptop and Team App \$1,653)

The accounts have been subject to an independent level of oversight pursuant to the undertaking previously given and your Committee have agreed that the Financial Statements as presented give a true and fair view of the financial performance and position of the Association during and at the end of the financial year.

I would like to thank all the members of Committee who have contributed many hours of time into the running of the Association. My thanks also to the members of the Operations Team who look after the cash on game days.

There will be no change proposed for our annual fees (\$40 with a rebate of \$5 to those Members who have attained the age of 70 and have completed five years of membership) or the nomination fee which will remain unchanged at \$80

I have pleasure in presenting these accounts to the Membership and would propose that the reviewed accounts as presented be approved and in accordance with our Rules that the annual and nomination fees as mentioned above also be approved.




