The committee has pleasure in submitting the Annual Report of the Association together with the Financial Statements for the financial year ending 30-6-2022

PRESIDENT'S REPORT – 2022

This will be my last Annual Report as President of MDVGA.

I advised Committee 2 years ago that I would be retiring from Committee and a succession plan was put in place.

Larry Wilson who has been an excellent contributor on Committee has been confirmed as President. Larry has been involved in operations and match duties, managing handicapping, member surveys, and in updating programmes for processing events and results. I congratulate him on taking up the role as President.

I have enjoyed my 10 years as President and particularly the support received from all Committee members.

Mention must also be made of 2 other retiring Committee members.

- Len Symons (Treasurer) who has worked closely with me on matters such as constitution reviews , rules , legal issues and processes and insurance matters. His knowledge and contribution has been outstanding.
- Kevin Milner (Webmaster) who has worked tirelessly in implementing the 'computerisation' of our processes moving from what was relied at times on manual recording and processes to what we have today. Kevin has spent many late nights implementing changes to fields for events following cancellations by players and dealing with problems of access to our website. His contribution cannot be underestimated.

Whilst there are changes to the Committee, I believe we have a strong team to deal with the future challenges and the retiring members would always make themselves available to assist if required.

The changes to the Committee are reflected in the remainder of the report.

THE PAST YEAR -

- Pandemic issues once again caused disruption to our events programme with 7 games cancelled between August and November last year. However since then some normality has been restored with no further cancellations.
- The events programme for 2023 has been finalised taking account of responses to the members survey. The programme will be available at the AGM.
- EFT arrangements have proved beneficial during the year with only minor disruptions. A new machine has recently been requested from the bank.
- The President's invitational event between Hume District and MDVGA was held in January at Gisborne a close match with MDVGA winning 10 to 9. The event has been conducted since 2010 and the record now sits at 8 wins MDVGA and 3 wins Hume. No match was conducted in 2012 and 2021. The match will again be conducted at Gisborne in January 2023.
- There has been ongoing work on website development and the match file to ensure ease of access and timely processing of fields and results.
- We have been working for some years to ensure insurance coverage for all districts and
 members with a statewide approach. With the support of the VVGA we are now a
 participant in a statewide insurance policy which has resulted in significant savings for
 the MDVGA.

TO THE FUTURE

Membership levels have again decreased - to 260 members. We have lost 90 members during the last twelve months.

Hopefully with a more settled future and ability to conduct regular events we can increase our membership over the coming year. We will need to review how we can publicise and increase membership numbers involving all members.

The results of our recent members survey have been reflected in our programming and mixture of events for 2023.

Whilst no increases in fees have been recommended for 2023 we must continue to monitor our ongoing expenses such as the EFT facility, website and booking system maintenance which cannot be avoided. It is also essential that we continue to collect subscription renewals by the normal date of 1 December 2022.

The difficulties associated with Covid and Lockdowns have presented many challenges. The Committee has worked tirelessly to ensure that when we were able to play, that events were conducted as smoothly and efficiently as possible.

My thanks therefore go to all members of Committee for their ongoing efforts over the years with the sole goal of ensuring members needs are met.

To you, the members thank you for your continuing membership and I look forward to seeing you at future events.

Looking forward to the new season with some new events and hopefully good scores.

CAPTAIN'S REPORT - 2022

This report covers the period between July 2021 and June 2022. This period was again marred with all events through to November being cancelled due to the Covid pandemic. The first event played was at Riversdale in late November. All events post Riversdale proceeded as normal, making the total number of events held in the 2021/2022 financial year 15 events when including the Hume District challenge.

The schedule in the first half of 2022 included two new courses; Kingswood Peninsula (South Course) and the Rosebud Country Club (North Course). In addition, Patterson River will be played for the first time in August 2022.

The attendance at events this year is down on previous years, with numbers ranging from around 50 to 90 players. A number of factors has impacted the decline with increased game costs and the lingering effects of the pandemic being the major contributors.

A major review of the event schedule was undertaken in May/June 2022 with the aim to increase member participation in 2023. The aim of the review was to base the 2023 schedule on the results of 2021 survey, courses with high participation and ensuring some course rotation. The 2023 schedule aims to restrict the more expensive courses to four and to spread these events evenly throughout the year, to more evenly spread the event localities between north, central and south, to play the most popular courses twice and lastly to include more team events.

The annual Presidents invitional event between Melbourne and Hume Districts at Gisborne was held in late January with Melbourne District winning a close contest 10 to 9.

The MDVGA website continues to be regularly updated with news and information, including the usual online booking features and match reports. The use of the ios and android application "Stack Team App" first introduced in 2021 continues being used to alert our members of News, Events, Results and Bookings.

Lastly, in late 2021 a major revamp of the Match Day Record Sheet was undertaken and my thanks goes to Ian Tait for his many hours developing the new sheet, the incorporation of additional features as testing went along and also to the redevelopment of the Golfer of the Year calculation sheet. The overall result is a simplified process for both the setting up, recording and finalising of each event.

Also, a thanks to all members of committee who have assisted me in the match duties to ensure that our games of golf run smoothly for the enjoyment of our members.

SECRETARY'S REPORT 2022

It was good to have an uninterrupted start to our 2022 golf calendar after experiencing interruptions for the last two years. Being able to play on our favourite host courses as well as our own home courses was a welcome relief from the pandemic riddled syllabuses of 2020 and 2021. As secretary I missed the regular meetings with event organisers at our host courses to discuss the organization of our golf days. I hope we can continue our uninterrupted golf for the remainder of 2022.

At the start of this year we conducted a survey to gauge member satisfaction with course selection over the past few years regarding green fees, popularity, and competitions played. The results of this survey has been incorporated into the 2023 syllabus as alluded to in the Captain's report. The 2023 syllabus will be released at the Liaison Officer's meeting on August 30th. One of the new courses we played this year was the revamped Peninsula Kingswood and although fairly expensive at \$160, the 47 members and guests who played were suitably impressed with the course. Most of these players were prepared to return in 2023 if costs were to be similar to this year. Unfortunately PK have indicated that the cost next year will be around \$200. Consequently we have not included PK in our 2023 syllabus.

Our President John Anstey and Kevin Milner our Webmaster (website, IT issues, match programming and statistics) have been long-serving members of our committee and have been nominated for Life Membership of MDVGA which I implore you to endorse at our AGM. John, recently has been instrumental in convincing the VVGA to take out state wide insurance to cover all the associations under the umbrella of the VVGA. This has resulted in cost savings to us and other veteran golf bodies in the VVGA. Kevin has worked tirelessly for years on our online booking program and Operations and Match programs to ensure a smooth running of our computer systems.

During this financial year of 2021/2022 we finally awarded Bobby Smith of Box Hill GC his Honorary Membership Certificate. Bill Rhoden of Woodlands GC was also awarded Honorary Membership.

A couple of "innovations" that have helped our Operations team on the mornings we play have been the card printing by the host clubs and the EFTPOS card payments by members. This has helped streamline our operations in the morning of our games. Because we give the names, golflink numbers and tee positions on the Friday to the host club (as requested) there may be a few tee position alterations between the Friday and the Monday when we play. These are handled by the Operations team early Monday morning.

I would like to thank our departing Liaison Officers for their efforts in being the contact person at their club for notices and recruiting. They are: Bruce Ayres (Heritage), Bernie Handke (Gisborne), Eifion Thomas (Keysborough), John Folan (Medway), Garth Hodge (Riversdale) and Steve Shaw (Cheltenham).

Finally I wish all the best to our retiring committeemen, President John Anstey, Webmaster Kevin Milner and Treasurer Len Symons who has been a great support to me during my relatively short period as Secretary. Also I welcome Brian Scott from Latrobe who will take over as treasurer and Tony Jones from Waterford Valley who also joins our committee.

TREASURER'S REPORT 2022

This year the Covid19 restrictions once again severely disrupted the activities of the Association with the first seven games of the financial year being cancelled and lower than usual numbers at our games due to members taking advantage of their ability to once again travel and those remaining also a bit wary of crowds.

While our Subscription income and New Members were both down this was basically matched by the drop in expenses largely as a result of the VVGA taking over the Insurance commitments for all Districts. While we had budgeted for a slight deficit of \$397 the actual result was very close with a deficit \$417.

Overall, the results for the year are considered acceptable in these troubled times and we are budgeting for a small surplus in the coming year & hope that all games will proceed as planned.

The accounts have been subject to an independent level of oversight pursuant to the undertaking previously given and your Committee have agreed that the Financial Statements as presented give a true and fair view of the financial performance and position of the Association during and at the end of the financial year.

I would like to thank all the members of Committee who have contributed many hours of time into the running of the Association. My thanks also to the members of the Operations Team who look after the registration process on game days.

As some of you may be aware, I am stepping down as your Treasurer after some 17 years, it has been a pleasure & a privilege to have been on Committee & represent you all. I have seen quite a number of people come & go from Committee during my time (in excess of 35) & I would like to thank them all for their assistance & contribution – it does make the role a lot easier. I would also like to thank Brian Scott for stepping up & taking over the Treasurer role & I wish him well.

As my final official role, I have pleasure in presenting these accounts to the Membership and would propose that the accounts as presented be approved.


